

Guidance Notes on Making Re-export Declaration

Export Licence (Textiles) Form 4 and paper Export Notifications II (Textiles) under the Textiles Trader Registration Scheme covering re-export of textiles must contain an appropriate declaration with respect to the date of arrival and the importing place of the textiles concerned.

2. Export Licence (Textiles) Form 4 applications covering re-export of textiles must contain the following declaration in the “Full Description of Goods” column :

- (i) For textiles imported from the Mainland of China (the Mainland) at any time or from other countries or places **before 20 May 2011**:

*“For re-export only. No manufacturing process has been carried out in Hong Kong on the goods described above which would permit the issue, in accordance with the origin criteria laid down by the Director-General of Trade and Industry, of a Certificate of Hong Kong Origin in respect of the goods. The goods were imported from (name of country/place) under *Import Licence(s)/Import Notification(s)/Comprehensive Import Licence(s) No(s) _____, (a) true copy(ies) of which is(are) attached herewith.”*

**Delete if inapplicable*

- (ii) For textiles imported from countries or places other than the Mainland **on or after 20 May 2011**:

“For re-export only. No manufacturing process has been carried out in Hong Kong on the goods described above which would permit the issue, in accordance with the origin criteria laid down by the Director-General of Trade and Industry, of a Certificate of Hong Kong Origin in respect of the goods. The goods were imported from (name of country/place) on (Date of Arrival).”

- (iii) For textiles partly imported from the Mainland **and** partly from other countries or places **on or after 20 May 2011**:

“For re-export only. No manufacturing process has been carried out in Hong Kong on the goods described above which would permit the issue, in accordance with the origin criteria laid down by the Director-General of

*Trade and Industry, of a Certificate of Hong Kong Origin in respect of the goods. The goods in item no. () were imported from (name of country/place) under *Import Licence(s)/Import Notification(s)/Comprehensive Import Licence(s) No(s) _____, (a) true copy(ies) of which is(are) attached herewith. The goods in item no. () were imported from (name of country/place) on _____(Date of Arrival).”*

3. Traders completing paper Export Notifications II (Textiles) covering re-export of textiles must provide the following information in the pre-printed “Exporter’s Declaration” box :

(i) For textiles imported from the Mainland at any time or from countries or places other than the Mainland **before 20 May 2011:**

- “Place of Origin”
- “Import Notification (Textiles)/Import Licence (Textiles)/Comprehensive Import Licence (Textiles) Unique Reference* No.”

(ii) For textiles imported from countries or places other than the Mainland **on or after 20 May 2011:**

- “Place of Origin”;

and the following declaration in the blank area under the “Full Description of Goods” column:

“I declare the goods were imported on _____(Date of Arrival).”

(ii) For textiles partly imported from the Mainland **and** partly from other countries or places **on or after 20 May 2011:**

- “Place of Origin”
- “Import Notification (Textiles)/Import Licence (Textiles)/Comprehensive Import Licence (Textiles) Unique Reference* No.”

and the following declaration in the blank area under the “Full Description of Goods” column for the textiles imported from countries or places other than Mainland:

“I declare the goods in item no. () were imported from (name of country/place) on _____(Date of Arrival).”
