- The words 'By Sea', 'By Air', 'By Train', 'By Road', 'By Post', or 'By Courier' as the case may be should be inserted. The relevant vessels or flight number may be given if they are known at the time of completing the notification.
- Storage address in full must be provided, if different from Importer's Address.
- Origin marking, if any, on the goods must be provided.
- Date of declaration must be inserted.
- HKID Card or Passport No. is not required.
- The notification must be signed.
- Company/business chop, not a small round amendment chop, should be stamped.
- The 8-digit Hong Kong HS Code No. corresponding to the textiles product concerned must be given.
