**TO THE MANAGER**

PLEASE BE ADVISED THAT AS OF TODAY, THE "**CERTIFICATE OF ORIGIN - RE-EXPORT**" (C. O-REX.) ISSUED IN HONG KONG BY ANY CHAMBER OF COMMERCE, **MUST COMPLY** WITH THE FOLLOWING REQUIREMENTS:

1. IT MUST BE ACCOMPANIED BY' A COPY OF THE **CERTIFICATE OF ORIGIN (C.O.)** FROM THE COUNTRY WHERE THE GOODS HAVE BEEN MANUFACTURED.

2. THE ACCOMPANYING **C.O.** MUST ONLY BE ISSUED BY THE. OFFICIAL AUTHORITIES OF THE COUNTRY WHERE THE MANUFACTURER IS LOCATED; A C.O. ISSUED BY THE MANUFACTURER WILL NOT BE ACCEPTED.

**NO OTHER ENDORSEMENT IN HONG KONG** WILL BE REQUIRED ON THIS DOCUMENT.

YOU ARE REQUESTED TO PRODUCE ORIGINAL C.O. PLUS 2 COPIES OF THE SAME.

AFTER COMPARING ORIGINAL AND COPIES, THIS CONSULATE GENERAL WILL ENDORSE AUTHENTICITY ONLY ON THE OFFICIAL COPY. THE ORIGINAL WILL BE RETURNED, WITHOUT ANY ENDORSEMENT, BACK TO THE CLIENT.

(For ex., goods manufactured in Guangdong, PRC, must be included in an official C.O. issued by the "China Council for the Promotion of International Trade Guangdong". This C.O. must accompany an exatimlar Certificate of Re-Export, as mentioned in the first paragraph)

3. NEITHER THE CERTIFICATE OF ORIGIN NOR THE CERTIFICATE OF RE-EXPORT WILL BE ENDORSED SEPARATELY DOCUMENTS NOT COMPLYING STRICTLY WITH THIS POLICY WILL NO BE ACCEPTED AND NO EXCEPTIONS WILL BE ENTERTAINED.
