☐ Trade Commission (Chairman: Lee, Young Lan) decided to start investigating dumping imports of ceramic tiles made in China and the damages caused to the domestic industry at the 222nd conference held on June 22, 2005.

* Ceramic tiles covered in the investigation are square tiles varying in size from 70 mm to 1300 mm manufactured from nonmetallic minerals such as clay, porcelain clay and feldspar through forming and plasticity process and are used for exterior/interior material and floor material for buildings.

☐ Four domestic ceramic tile manufacturers including Daedong Industrial Co.,Ltd, DaeBo Ceramics Co.,Ltd, Hanbo Ceramics Co.,Ltd, and Sungil Ceramics Co.,Ltd applied on April 29, 2005 to the Trade Commission for investigation on dumping imports of ceramic tiles made in China with a view to applying anti-dumping duties to such imports.
