<sup>&</sup>lt;sup>1</sup> Under this section, an owner, in respect of a vessel, aircraft or vehicle, means -

<sup>(</sup>a) the registered owner and any person holding himself out to be the owner thereof;

<sup>(</sup>b) any person acting as agent for the owner in connexion with the handling of cargo carried in or on the vessel, aircraft or vehicle;

<sup>(</sup>c) any person to whom the vessel, aircraft or vehicle has been chartered or hired; and

<sup>(</sup>d) any person having for the time being the control or management of the vessel, aircraft or vehicle.

- (b) only carries on a business of carrying rough diamonds and does <u>not</u> carry on a business of importing, exporting, buying or selling rough diamonds;
- (c) has to fulfil the following obligations under the Ordinance when rough diamonds are imported or exported on my vessel, aircraft or vehicle
  - (i) not to release rough diamonds imported unless there is a valid import licence , i.e., KP Certificate (Import), for the shipment (section 7(1));
  - (ii) not to accept rough diamonds for export unless there is a valid export licence, i.e., KP Certificate (Export), for the shipment (section10(1)(a));
  - (iii) to deliver to the Director-General of Trade and Industry (DGTI) the import licence, i.e., KP Certificate (Import), for the shipment together with the manifest of the vessel, aircraft or vehicle on which the goods were imported (section 8(2)(b)); and
  - (iv) to deliver to DGTI the export licence, i.e. KP Certificate (Export), for the shipment together with the manifest of the vessel, aircraft or vehicle on which the goods were exported (section 11(2)(b)); and
- (d) is <u>not</u> an importer/an exporter/a buyer/a seller in respect of the rough diamond trading business activities stated in my Application Form for New Registration/ Renewal of Registration as a Rough Diamond Trader \* *(please delete as appropriate)* filed with DGTI.

<u>An extract of the manifest</u> of the import/export\* (*please delete as appropriate*) shipment of rough diamonds/ other products\* (*please delete as appropriate*) delivered by my company/registered business to DGTI is attached as supporting document.
