- Origin marking, if any, on the goods must be provided.
- Date of declaration must be inserted.
- HKID Card or Passport No. is not required. (New notification form will be printed).
- The notification must be signed.
- Company chop, not a small amendment chop, should be stamped.

- Errors should be clearly crossed out, with the amendments clearly entered next to them. The Exporter must endorse every amendment, defacement, addition or deletion on the notification form by stamping the Exporter's small amendment chop in blue and initialling with date adjacent to each and every amendment on every copy.
 - The amendments made must be clear and legible, and must not deface the other particulars on the form. No erasure or correcting fluid is allowed.
 - Amendment can only be made on the original (TRADE DEPARTMENT'S COPY) of a full set of notification form with the EXPORTER'S copy together. Amendment to any separated copy by the trader is not allowed.
