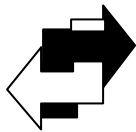

**Personal Information Collection Statement**

They may however be disclosed to other government departments, or to third parties in Hong Kong or elsewhere, if such disclosure is necessary for facilitating consideration of the application, is in the interests of the trade in Hong Kong, is authorised or required by the law; or if explicit consent to such disclosure is given by the applicant/data subject.

**Right of Access to and Correction of Personal Data**

Applicant/data subject whose personal data are collected by the Department may request access to them under the Personal Data (Privacy) Ordinance. A charge will be made to cover the cost of photocopying the data supplied. In addition, if the applicant/data subject considers that the data supplied to Trade and Industry Department are inaccurate, a request for correction of the personal data may be made after a data access request has been complied with.
