2. The signatory, on behalf of the registered rough diamond trader, understands that utilisation of services and access to information provided in the E-Account is subject to the conditions listed below. The signatory hereby agrees on behalf of the registered rough diamond trader that he/she has read and understood these conditions and undertakes to comply with them.

**Conditions 條件**

**General 一般條件**

(a) E-Account services are only available for rough diamond trader registered with the Trade and Industry Department (TID). Rough diamond trader with invalid registration may be denied access to E-Account and/or the related services without prior notifications.

電子帳戶只供已在工業貿易署〈工貿署〉登記的未經加工鑽石商使用。如未經加工鑽石商的登記無效，本署無須事先通知可以取消其電子帳戶及有關服務使用權。

(b) Each E-Account is a dedicated account for the registered rough diamond trader and its use is exclusively at the discretion of the registered rough diamond trader, i.e. the E-Account holder.

每個電子帳戶均屬該已登記未經加工鑽石商戶口，其使用權全由該已登記未經加工鑽石商（即電子帳戶持有人“帳戶持有人”）自行決定。

- (c) The conditions of use for E-Account may be updated and revised by the TID from time to time.  
本署日後可隨時就電子帳戶的使用條件作出更新和修改。
- (d) E-Account holder when making electronic applications for pre-vetting in their E-Accounts are further subject to conditions imposed by the Director-General of Trade and Industry for such applications which may be stipulated in the applications and/or announced through circulars published by TID.  
帳戶持有人在電子帳戶辦理電子申請供本署作預先審批，亦須同時符合工貿署署長於申請書或通告內公佈的有關申請條件。

#### **Provision of Services and Information 提供的服務及資料**

- (e) The service and information is provided in the E-Account on an “as is” basis. TID assumes no responsibility for the untimeliness, deletion and mis-delivery of information or failure of the services provided on the TID Web.

- (f) The technical processing and transmission of the services and information concerned may involve data transmission over various networks; and changes in data format to conform and adapt to technical requirements of connecting networks or devices. TID shall, accordingly, in no circumstances, be liable for any failure of delivery of services and information or for any inability to gain access to any of such services and information due to the delay or failure of any communication networks or any party providing such access.

#### **Collection of Personal Information 收集個人資料**

- (g) E-Account holder is required to provide certain personal data in activating and using his/her E-Account. The data will be used by TID for facilitating provision of services/information through the E-Account and ensuring that the E-Account is used by the authentic and eligible user. E-Account holder providing incomplete or inaccurate data may be denied access to the E-Account and is ineligible for using the services and information on the TID Web.

- (h) The TID is committed to ensuring that all personal data provided in the E-Account are handled in accordance with the relevant provisions of the Personal Data (Privacy) Ordinance.

- (i) E-Account holder should further refer to the relevant Personal Information Collection Statements pertaining to the respective web-based services for electronic applications available in their E-Account.

- (j) E-Account holder is responsible for maintaining the confidentiality and authorized uses his/her Login ID (user name) and Password and is fully responsible for all activities that occur with the use of the Login ID (user name) and Password.

- (m) The use of services and information in the E-Account is at the own discretion and risk of the E-Account holder. TID will not accept any liability for loss or damage resulting from (i) the use of and inability to use the services and information obtained through or from the E-Accounts; (ii) events of interrupted or delayed services and information; and (iii) unauthorized access to or alteration of applications and particulars made in the E-Accounts.
