Remarks

- Errors should be clearly crossed out, with the amendments clearly entered next to them. The Exporter must endorse every amendment, defacement, addition or deletion on the notification form by stamping the Exporter's small amendment chop in blue and initialling with date adjacent to each and every amendment on every copy.
- The amendments made must be clear and legible, and must not deface the other particulars on the form. No erasure or correcting fluid is allowed.
- Amendment can only be made on the original (TRADE DEPARTMENT'S COPY) of a full set of notification form with the EXPORTER'S copy together. Amendment to any separated copy by the trader is not allowed.

Requirements specific to the Completion of
an Export Notification I (Textiles) covering Exports
of Textiles of Hong Kong Origin to Iceland, Liechtenstein, Switzerland
and Turkey and Textiles Samples of Hong Kong Origin to Non-restrained Markets

Textiles Exports to Iceland, Liechtenstein, Switzerland and Turkey

In completing an Export Notification I (Textiles) for export of textiles products to Iceland, Liechtenstein, Switzerland and Turkey, the actual weight of the textiles products in kg should also be provided in the *No. of Units* column. If the consignment covers apparel for men, women, boys, girls and/or infants, separate breakdown in respect of weight of adults' apparel (i.e. for men and women), children's wear (i.e. for boys and girls) and infants' wear should be provided. If a consignment covers products of a range of sizes, the weight of each and every size in the range must be taken for the purpose of arriving at the weight of the consignment in question.

Textiles Samples of Hong Kong Origin to Non-restrained Markets

2. For an Export Notification I (Textiles) covering the export of textiles samples of Hong Kong origin to non-restrained markets, the *Manufacturer (Name and Address)* column, the *Manufacturer's TT Registration No.* column and the *Manufacturer's Declaration* column can be left blank if the samples satisfy the following conditions :

- (i) The articles are bona fide commercial samples not for sale in the importing country.
- (ii) Each consignment does not exceed the following quantitative limit :
 - (a) 300 pieces/pairs of garments; or
 - (b) 300 units of made up articles; or
 - (c) 90 square metres of woven fabrics; or
 - (d) 30 kilogrammes of garment parts or yarn or knitted fabrics.

In this connection, textiles goods exported on the same carrier for the same consignee is regarded as one consignment.

- (iii) Goods covered by one notification are not packed or invoiced together with goods not covered by the same notification.
- (iv) The *Full Description of Goods* column of the notification should bear a declaration reading "Samples of No Commercial Value".
- (v) The *Exporter's Declaration* column of the notification should bear a declaration reading "I further declare that the goods are of Hong Kong origin".
