BACKGROUND:

On May 24, 1989, U.S. Customs provided a list of tariff numbers that required a formal entry regardless of value because of quota/visa concerns and another list of HTS numbers in which a formal entry was required because of legislative requirements. Some of these HTS numbers may appear in both lists, and in those cases the requirement for formal entry regardless of value will take priority. The following is an update of this original list.

ACTION:

1) The following HTS numbers will require formal entry if valued in excess of \$250 (19 CFR 143.21a):

2) The following HTS numbers require the submission of a formal entry for commercial shipments only, regardless of value (19 CFR 143.22). For these tariff numbers, "freight charges" are required only for line items valued over \$250.

3) Visa or quota countries for which informal entries are allowed for properly marked commercial sample shipments (despite the above classifications) if valued at \$250 or less. (Note: Properly marked commercial sample shipments do not require a visa if valued at \$800 or less, however, 19 CFR 143.21 (a) requires a formal entry if valued at greater than \$250.)

4) Countries not available for properly marked commercial sample shipments are shown below. Formal entries regardless of value must be filed if classified in one of the HTS numbers shown in provision (2), even if a properly marked commercial sample shipment.
