Decree of

containing Azo Dyes Decree
pursuant to the Consumer Goods Act

On the recommendation of the State Secretary of Public Health, Welfare and Sport dated 28 November 1997, GZB/C&O/976674, made in agreement with Our Minister of Economic Affairs.

Having regard to Section 4, Subsection 1, of the Consumer Goods Act;

Having heard the Council of Sate (recommendation of, no. W....);

Having regard to the detailed report of the State Secretary of Public Health, Welfare and Sport of issued in agreement with Our Minster of Economic Affairs;

Have approved and understood:

Article 1

In this Decree the following terms are used with the meaning indicated:

- a. aromatic amines: the compounds named in Appendix I to this Decree;
- azo dye: dye the structure of which is characterised by the presence of a unit of two nitrogen atoms with a double mutual bond;
- pigment: a compound consisting of particles, practically insoluble in the application medium, which is used as a dye.

Article 2

It is prohibited to trade in clothing, footwear and bedlinen which do not satisfy the requirements laid down in this Decree with regard to their composition or properties.

Article 3

- Clothing, footwear and bedlinen shall not contain any azo dyes from which aromatic amines may be formed.
- Subsection 1 is not applicable to clothing, footwear and bedlinen in which the azo dyes referred to in Sub-section 1 are only present as a pigment.

Article 4

- The testing methods in Appendix II to this Decree are exclusively decisive for the establishment of whether the requirements stated in this Decree are or are not satisfied with regard to clothing, footwear and bedlinen.
- Notwithstanding Subsection 1, other testing methods may also be used for the establishment of whether the requirements stated in this Decree are or are not satisfied with regard to clothing, footwear and bedlinen with regard to the goods just mentioned if these goods, within another Member State of the European Union or a state which is a party to the Agreement relating to the European Economic Area, have been produced and legally marketed here and these methods provide results which are comparable with those obtained using the testing methods stated in Appendix II.

Article 5

This Decree enters into force with effect from the first day following the date of issue of the Bulletin of Acts and Decrees in which it is placed, with the understanding that second-hand clothing, footwear and bedlinen, as well as clothing, footwear and bedlinen also being personal protective equipment as referred to in Article 1 (a) of the Decree pursuant to the Consumer Goods Act, and clothing, footwear and bedlinen manufactured from recovered fibres in which the azo dyes referred to in Article 3 Sub-section 1 are present may continue to be traded until 31 December 1999.

Article 6

This Decree is quoted as the: Azo Dyes Decree pursuant to the Consumer Goods Act.

Order and instruct that this Decree with the associated explanatory notes will be placed in the Bulletin of Acts and Decrees.
