COMMUNIQUÉ

From the Undersecretariat for Foreign Trade:

**COMMUNIQUÉ ON THE REGISTRATION OF IMPORTS
OF TEXTILES AND READY GARMENTS**

IMPORT: (2009/21)

Scope

ARTICLE 1 – (1) This Communiqué covers principles and procedures concerning prior registration of imports of textiles and apparel indicated in the customs tariff positions and chapter numbers shown in **APPENDIX I**.

Registration

ARTICLE 2 – (1) Importers wishing to import products indicated in the first article of this Communiqué shall register, prior to import, information concerning the imports they wish to make, at the “Registration Centres” indicated in **APPENDIX II** and authorized by the Undersecretariat for Foreign Trade. A “Registration Certificate” will be drawn up to show that the import procedure has been registered.

(2) Products indicated in the first article of this Communiqué shall not be subject to registration where the quantity of the goods to be imported under the relevant customs tariff statistical position, within the scope of a customs declaration, is 5 kg gross weight or less.

Imports

ARTICLE 3 – (1) The “Registration Certificate” indicated in the second article of this Communiqué or registration in an electronic environment shall be required by customs authorities at the point of registration of customs declaration of release for free circulation, irrespective of the country of origin.

Application

ARTICLE 4 – (1) For applications requesting registration certificates to be considered, the “Registration Certificate Application Form” supplied at **APPENDIX III** must be duly and fully completed, and forwarded to one of the registration centres, together with all the documents appended to this form, without omission. Where necessary, supplementary information and documents may be requested.

Processing of the application

ARTICLE 5 – (1) Duly and fully completed registration certificate applications will be processed within a maximum of 10 (ten) working days.

(2) Where it is determined that a false declaration has been made, or where there is inconsistency between the information and documents included within an application, or where

there is grave suspicion of the foregoing, no registration certificate will be issued until the relevant matters have been resolved. Such applications will be referred by the relevant registration centre to the coordinator registration centre for evaluation.

Information concerning the registration certificate and use thereof

ARTICLE 6 – (1) The period of validity of registration certificates shall be 90 (ninety) days. A registration certificate may not be used for more than one declaration, and its term may not be extended.

(2) A registration certificate shall not interfere with the implementation of provisions of the Customs Law concerning “Customs Value of Goods,” and may not be used to substitute for other documents required by regulatory provisions.

(3) Where the value or quantity identified and agreed by customs authorities at the point of registration of the customs declaration exceeds, by a total of 5% (including 5%) or less, the value or quantity registered in the registration certificate, this shall not prevent the import of those goods.

(4) The registration certificate may not be transferred to third parties.

Regulatory measures withdrawn

ARTICLE 7 – (1) Communiqué on The Registration Of Imports Of Textiles And Apparel and appendices thereto, number 2008/21, as published in Official Gazette number 26743 of 31/12/2007, has been withdrawn.

Entry into Force

ARTICLE 8 – (1) This Communiqué shall enter into force on 1/2/2009.

Enforcement

ARTICLE 9 – (1) The respective Minister for the Undersecretariat for Foreign Trade shall enforce the provisions of this Communiqué.

(Required for initial application. In subsequent applications, photocopies will be sufficient. Where there is a change in the persons authorized to give their signature and/or where the period of validity of the resolution for signatory authority has expired, the original of the new document, certified by a notary, must be brought.)
- 2:** An "Importer Information Form approved by a certified financial consultant" as shown below will be required for all producer importers at their first application in each calendar year.
- 3:** The Exporter Registration Form shown below will be required upon application for the first import from each different exporter. The Exporter Registration Form, following approval by the competent authorities in the relevant country, shall be submitted for certification by one of the Consulates of the Republic of Turkey in the same country. Where there is no Consulate of the Republic of Turkey in the country in question, the document shall be approved by the producer's respective foreign chamber of commerce.
- 4:** The Materials Information Form shown below (information concerning invoice items must be entered.)
- 5:** For goods subject to Knitted/Woven Cloth and Fibre Detail Declaration, Knitted/Woven Cloth and Fibre Detail Declaration Form
