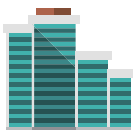

The Trade and Industry Department (TID) handles the Hong Kong Special Administrative Region (HKSAR)'s commercial relations with its trading partners, and protects Hong Kong's trade interests and rights. The TID offers support to various sectors, in particular small and medium enterprises (SMEs), and provides services for locally based trade and industrial organisations and businesses. It also provides local enterprises with updated information on changes in major trading partners' trade-related laws, regulations and policies.

Funding Schemes



Dedicated Fund on Branding, Upgrading and Domestic Sales (BUD Fund)

Provide funding support to non-listed Hong Kong enterprises in developing brands, upgrading and restructuring their business operations, and promoting sales in those markets with which Hong Kong has signed free trade agreements and/or investment promotion and protection agreements, so as to facilitate their business development in those markets.



SME Export Marketing Fund

Provide funding support to non-listed Hong Kong enterprises for participation in promotion activities to expand markets.



Trade and Industrial Organisation Support Fund

Provide funding support to non-profit-distributing organisations to implement projects which aim at enhancing the competitiveness of non-listed Hong Kong enterprises in general or in specific sectors.

Import and Export of Goods

Import and Export Licensing and Control, and Registration Schemes

Hong Kong is a free port. There is no customs tariff on imports or exports, but certain goods are subject to import/export control in Hong Kong. The TID is responsible for the licensing and/or registration of the following goods:

Transshipment Cargo Exemption Scheme

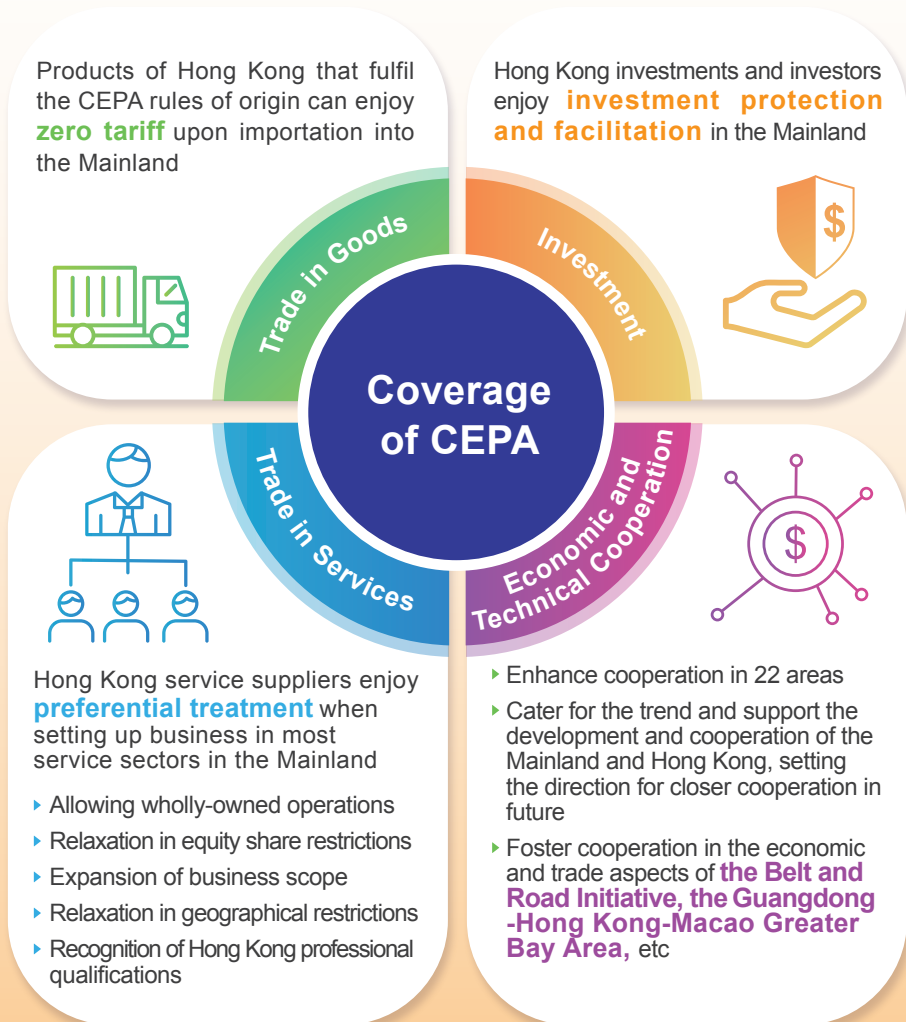
Shipping companies, airlines and freight forwarders registered with the TID under the scheme are, subject to certain conditions, exempted from import and export licensing requirements in respect of transshipment cargoes they handle.

Certificate of Origin

The TID provides an origin certification service to facilitate Hong Kong's exports to other markets or to meet the requirements of importing authorities, as well as to enable traders to enjoy preferential tariff treatment under free trade agreements signed between Hong Kong and other economies. Manufacturers registered under the TID's Factory Registration can apply for Certificates of Origin to certify the origin of the relevant exports.

Mainland and Hong Kong Closer Economic Partnership Arrangement

The Mainland and Hong Kong Closer Economic Partnership Arrangement (CEPA) was signed in June 2003. It is a free trade agreement signed between the Mainland and Hong Kong which fosters the joint development of the two places through mutually beneficial market liberalisation and economic and trade cooperation. The TID has been working closely with the Mainland authorities to continuously enrich the content of CEPA.



Trade Relations

Hong Kong actively supports and promotes a free, open and stable multilateral trading system. Through participating in multilateral, regional, plurilateral and bilateral trade agreements, Hong Kong secures, maintains and improves access to foreign markets for its goods and services. Under the Basic Law, the HKSAR shall be a separate customs territory and may on its own, using the name "Hong Kong, China", maintain and develop relations and conclude and implement agreements with other economies and regions, and participate in relevant international organisations in the economic, trade and other appropriate fields.

The TID coordinates HKSAR's participation in the World Trade Organization, the Asia-Pacific Economic Cooperation, the Organisation for Economic Co-operation and Development's Trade Committee, and the Pacific Economic Cooperation Council.

Hong Kong's Free Trade Agreements and Investment Promotion and Protection Agreements

The TID enhances economic co-operation with trading partners, assists enterprises in diversifying markets and securing better market access, and strengthens protection of investors' overseas investments through forging free trade agreements (FTAs) and investment promotion and protection agreements (IPPAs).

So far, Hong Kong has signed 9 FTAs with 21 economies:

The Mainland of China; Macao Special Administrative Region;
New Zealand; Chile; Georgia; Australia; Peru;
Member States of the Association of Southeast Asian Nations (ASEAN)
(viz. Brunei Darussalam, Cambodia, Indonesia, Laos, Malaysia, Myanmar,
The Philippines, Singapore, Thailand and Vietnam);
Member States of the European Free Trade Association
(viz. Iceland, Liechtenstein, Norway and Switzerland).

All FTAs, except the one with Peru, have entered into force

As of March 2025, Hong Kong has signed 24 IPPAs with 33 foreign economies:

10 ASEAN Member States; Australia; Austria; Bahrain; Belgium; Canada;
Chile; Denmark; Finland; France; Germany; Italy; Japan; Korea; Kuwait;
Luxembourg; Mexico; The Netherlands; New Zealand; Sweden;
Switzerland; Türkiye; United Arab Emirates and United Kingdom.
