Noting the vital role that professional services play in facilitating bilateral trade and investment, as well as regional and global trade and investment flows, and pursuant to paragraph 6 of Annex 8-A (Professional Services) of Chapter 8 (Trade in Services) of the Agreement, Peru and Hong Kong, China shall enter into discussions to explore ways to facilitate recognition of existing relevant professional experience for the purpose of the fulfilment of a Party's standards or criteria for the registration, authorisation, licensing or certification of service suppliers.

I have the honour to propose that this letter and your letter of confirmation in reply, both being equally authentic in the English and Spanish languages, constitute an agreement between Peru and Hong Kong, China, which shall enter into force on the date of entry into force of the Agreement.
