<u>General Notes 一般事項</u>

- 1. The application fee for renewal of Registration as Hong Kong Registered Wine Exporters is **HK\$210.** 香港「備案葡萄酒出口商」登記續期申請費用為**港幣 210元**。
- 2. Applicants are advised to **make payment after preliminary verification of the renewal application form and the required supporting documents by the Trade and Industry Department (the Department)**. Payment of the requisite application fee does not guarantee approval by the Director-General of Trade and Industry. Any request for refund of the application fee paid will not be accepted irrespective of whether the application is approved or not.

Payment Procedures 繳款程序

- (i) For application to be delivered in person
 - 適用於以專人遞交的申請
- Please present the duly completed fee demand note at the Shroff and Form Sales Counter of the Department in Room 1309 on 13/F of the Trade and Industry Tower (the Tower), 3 Concorde Road, Kowloon City, Hong Kong and pay the application fee by means of (i) crossed cheque; (ii) cash; (iii) Easy Pay System (EPS); or (iv) Faster Payment System (FPS). Payment by cheque should be made payable to "The Government of the Hong Kong Special Administrative Region".

Please pay the application fee for renewal by e-Cheque; through online credit card or online FPS payment via the Department's e-Payment Platform Portal https://www.tid.gov.hk/epay?lang=en_US; or by mailing the crossed cheque and duly completed fee demand note to the Registration Unit for Hong Kong Registered Wine Exporters on 14/F of the Tower. The e-Cheque or crossed cheque should be made payable to "The Government of the Hong Kong Special Administrative Region".

The Department will process the renewal application upon receiving the documents stated in (iii) 1 above, and the duly completed application form and the required supporting documents submitted electronically via the above service.
