## SIMA – Preliminary Determinations respecting certain pup joints from the People's Republic of China

On December 12, 2011, the Canada Border Services Agency (CBSA) made preliminary determinations of dumping and subsidizing, pursuant to subsection 38(1) of the *Special Import Measures Act* (SIMA), in respect of oil country tubular goods pup joints, made of carbon or alloy steel, welded or seamless, heat-treated or not heat-treated, regardless of end finish, having an outside diameter from 2 3/8 inches to 4 1/2 inches (60.3 mm to 114.3 mm), in all grades, in lengths from 2 feet to 12 feet (61 cm to 366 cm) originating in or exported from the People's Republic of China.

The goods in question are usually classified under the following Harmonized System classification numbers:
