

Decree No. 509 of the Ministry of Finance and Economy

REGULATION CONCERNING THE IMPOSITION OF ANTI-DUMPING DUTY ON CERAMIC TILES PURSUANT TO ARTICLE 51 OF THE CUSTOMS ACT

Article 1 (Objective)

The objectives of this regulation are to designate the products and the suppliers subject to the imposition of anti-dumping duty and to determine the rate of the anti-dumping duty pursuant to Article 51 of the Customs Act.

Article 2 (Products subject to the Imposition of Anti-Dumping Duty)

The products subject to the imposition of anti-dumping duty are Ceramic Tiles under HSK 6907.90.1000, 6907.90.9000, 6908.90.1000, 6908.90.9000, and 6901.00.3000 originating from China in square shape not less than 70mm but not more than 1300mm in both width and height.

Article 3 (Suppliers Subject to This Regulation)

The suppliers subject to the imposition of anti-dumping duty under this Regulation are the suppliers of the products referred to in Article 2.

Article 4 (Anti-Dumping Duty Rate)

The rates of anti-dumping duty are as specified in the attached table.

ADDENDA

- ① (Enforcement Date) This Regulation shall be effective from December 30, 2005.
- ② (Applicable Period) This Regulation shall be applied until December 29, 2010.
