Such measures include, <i>inter alia</i>, the establishment of restrictions or limitations on current payments and transfers (capital movements) to or from Chile, as well as transactions related to them, such as requiring that deposits, investments or credits from or to a foreign country, be subject to a reserve requirement (“<i>encaje</i>”).</p> <p>ii. Commercial Presence (Mode 3)</p> <p>This Schedule applies only to the following types of commercial presence for foreign investors: public corporations open or closed (“<i>sociedades anónimas abiertas y cerradas</i>”), private-limited companies (“<i>sociedades de responsabilidad limitada</i>”), and subsidiaries (“<i>agencias de sociedades extranjeras</i>”).</p> <p>Real estate acquisitions and the performance of other legal acts in border areas must comply with the provisions of the relevant legislation, which is unbound for the purposes of this Schedule. The border area is defined as land situated within a distance of 10 km from the border and up to 5 km from the coast and the province of Arica.</p> <p>iv.
