<b>Sector:</b>	Fishing
<b>Sub-sector:</b>	-
<b>Legal source or authority of the measure:</b>	Resolution #138 of the Government of Georgia (August 11, 2005) on "Approval of Regulations on Rules and Conditions on Issuance of Fishing License"
<b>Succinct description of the measure:</b>	Fishing license can be granted only to the resident juridical or natural persons of Georgia.
<b>Purpose or motivation of the measure:</b>	Fisheries policy considerations.

<b>Sector:</b>	Agriculture
<b>Sub-sector:</b>	Agricultural Cooperation
<b>Legal source or authority of the measure:</b>	Law of Georgia on “Agricultural Cooperative” (July 12, 2013)
<b>Succinct description of the measure:</b>	<p>A member of an agricultural cooperative may be an 18-year or older citizen of Georgia and/or agricultural cooperative registered in Georgia, which directly participates in agricultural activities carried out by the cooperative and owns membership share.</p> <p>The citizen of foreign country and/or other legal entity of private law (including legal entities registered in foreign country) has a right to be an associated member of the agricultural cooperative, provided they have contributed membership fee, based on this law or decision of cooperative members’ assembly.</p> <p>The associated member may participate in an assembly, but he/she has only the right of deliberative vote.</p> <p>The associated member has the right to receive dividends from the contributed membership fee; He/she can be elected as the member of the supervisory board or executive council.</p> <p>The associated member may not be directly involved in agricultural activities carried out by the agricultural cooperative.</p>
<b>Purpose or motivation of the measure:</b>	Agricultural cooperation policy considerations.

<b>Sector:</b>	Agriculture
<b>Sub-sector:</b>	Purchasing of a state owned agricultural land
<b>Legal source or authority of the measure:</b>	Law of Georgia on “State Property” (July 21, 2010)
<b>Succinct description of the measure:</b>	<p>A state owned agricultural land can be purchased by the citizen of Georgia or a private legal entity, registered in Georgia.</p> <p>Georgia reserves the right to maintain or amend the measure or adopt any other measure with respect to agricultural land.</p>
<b>Purpose or motivation of the measure:</b>	Land policy considerations.

<b>Sector:</b>	Power and Energy
<b>Sub-sector:</b>	-
<b>Legal source or authority of the measure:</b>	Not applicable
<b>Succinct description of the measure:</b>	Georgia reserves the right to maintain or adopt any measure with respect to the power and energy sector.
<b>Purpose or motivation of the measure:</b>	Energy policy considerations.
